On September 26, 2007 an Order to Show Cause was issued to Wayne H. Bowman dba Anaconda Taxi, Walkerville, Montana, PSC No. 9431, for failure to file liability insurance. The Order to Show Cause was sent by certified mail and has been returned as unclaimed.

Class B – Passengers within Anaconda, Montana and points and places within a fifty (50) mile radius thereof. LIMITATIONS: 1) Transportation as a limousine or bus is prohibited. 2) Transportation of passengers originating within the city limits of Butte, Montana is prohibited.

STAFF RECOMMENDATION: Cancel PSC No. 9431 for failure to file liability insurance.

Transportation of ashes, trash, waste, refuse, rubbish and garbage is prohibited.
