Action Items All items identified below are for action at the Commission business meeting.

1. T-07.49.ST (Wayne)

On November 21, 2007 Steven and Mary Assmus dba Mining City Taxi, Butte, Montana filed an application to transfer PSC No. 321 to Mining City Taxi LLC, Butte, Montana. The application for transfer was noticed to the public on December 4, 2007 and no protests were received. Carrier has

agreed to the cancelation of Sub A due the de-regulation or pre-emption of that commodity from the Commission's jurisdiction.

Class B - Persons, in the City of Butte, Montana and to or from points not exceeding fifty (50) miles of Butte, Montana.
Limitations: Regular or scheduled service as a jitney or bus is prohibited on or over any route.

SUB A Class C - Air freight, between the Butte Airport and points and places within the City of Butte, Montana and an area of ten (10) miles.

STAFF RECOMMENDATION: Approve the transfer of PSC No. 321, as applied for and cancelling Sub A as the Commission no longer regulates air freight.

2. T-08.2.ST (Wayne)

On December 26, 2007 Alan H. Stacey dba Superior Moving, Great Falls, Montana filed an application for transfer of PSC no. 2848 to Superior Moving and Storage LLC, Great Falls, Montana. The application was noticed to the public on January 4, 2008 and no protests were received.

Class B - Household goods (as defined by Commission) from Great Falls, and points and places within a radius of 10 miles in any direction from said city to all points and places in the State of Montana and from all points and places in the State of Montana to Great Falls and points within a radius of 10 miles in any direction from said city.
