8 **Procedural Background.** On February 6, 2015 (Order No. 7084i) ruled in favor of
9 NorthWestern granting NorthWestern's April 17, 2014, Motion to Strike much of Testimony of
10 Complainants' witness Edward Smalley; and NorthWestern's April 1, 2014, Motion to Strike
11 some of Complainant's other testimony. Complainants were given until February 27, 2015 to file
12 amended testimony. On February 13, 2015, Order No. 7084j granted some of complainant's
13 spring 2014 motions to compel discovery and denied others. NorthWestern was given until
14 February 27, 2015 to comply with ordered discovery. It is anticipated that a further Order No.
15 7084k will be issued on pending motions.


16 **MOTION**


